

# National seat status fact sheet: 2025 federal election

This fact sheet provides the status of federal electoral divisions (seats) heading into the 2025 federal election. These margins reflect the <u>results of the previous federal election in 2022</u> while also, where possible, taking into account changes to electoral boundaries since that time.

The purpose of this document is to be a resource showing the two-candidate preferred (TCP) margin for each House of Representatives seat as of the most recent federal election. This document is not intended to predict in any way the results of the 2025 federal election, or the likely success of any given candidate or political party.

# TALLY ROOM

Seat margins in this fact sheet will be the starting point in the 2025 federal election tally room for measuring a swing.

# What is a margin?

A House of Representatives candidate is elected if they gain more than 50 per cent of formal votes in their electorate. The margin is the percentage of votes above 50 per cent received by the winning candidate.

Margins can be used to calculate the 'swing' of votes required to win or lose a seat. For example, if a candidate won a seat at the 2022 federal election with a margin of 52 per cent of the vote, a swing of 2% of votes would be required for another candidate to win the seat at a future election.

#### Seat status classifications

- marginal (M): < 56%
- fairly safe (FS): 56 60%
- safe (S): > 60%

The AEC uses the margin of the count between the 'final two' candidates to classify seats as either marginal, fairly safe or safe – as reflected above.



### Classic & non-classic results

For many decades, almost all House of Representatives contests result in the 'final two' candidates being from the ALP and Coalition. Therefore these results are colloquially known as 'classic' seats.

**pp. 5-12**: At the 2022 federal election 124 out of 151 (82%) seats had a classic result. These seat margins are reflected in the tables on pages 5-12 of this fact sheet.

**pp. 13-14**: The remaining 27 seats are categorised by the AEC as 'non-classic'. One non-classic seat was North Sydney, which has since been abolished as part of the NSW redistribution. The other 26 non-classic seat margins are available on pages 13 and 14.

# **By-elections**

Since the previous federal election in 2022 by-elections have been conducted in Aston (VIC), Fadden (QLD), Dunkley (VIC) and Cook (NSW).

Three of those by-elections have occurred in states where boundaries have been redrawn. By-elections are conducted on the boundaries in place at the previous full federal election. As such, the AEC cannot transfer by-election results onto any new boundaries.

# 🔌 Redrawn boundaries

Since the previous federal election, the boundaries of seats have been redrawn in NSW, VIC and WA.



As part of these redistribution processes one additional seat was created – the division of Bullwinkel in Western Australia (Image left: <u>Vivien Bullwinkel</u>). In addition, the seats of North Sydney in New South Wales and Higgins in Victoria were abolished. As a result, a total of 150 seats will be contested at the 2025 federal election.

No seat names were changed as part of the redistribution process in any state or territory.

The Northern Territory redistribution will be complete in March 2025.

# Notional margins

In states that have had boundaries redrawn, seat margins are calculated by applying voting patterns to the new boundaries that will be in place for the 2025 federal election. This notional seat status endeavours to provide the margin that a party or candidate would have won the seat by if the new boundaries applied.

Notional margins listed in this fact sheet will be used in the 2025 federal election tally room only to provide a basis upon which swings can be calculated. Others external to the AEC who also publish swing data, such as media outlets, may adopt all or part of this information. In our experience, most media outlets will use this information as one input into formulating their own swing data. The AEC is not otherwise involved in the decisions made about swing data by those external to the AEC.

In some non-classic seats, the mathematic hypothesis exercise for calculating starting margins in redrawn seats is more difficult. Ultimately, some AEC margin calculations will differ from others who are external to the AEC and do their own calculations. This is explained further below.

#### Calculating margins for Independents

Boundary changes have occurred to seats won by, and contested by, Independent candidates at the 2022 federal election. As Independent candidates are not part of a formal group, the AEC cannot calculate voting patterns in the same way they are calculated for registered political parties.

Transferring results from an independent candidate in one seat to an independent candidate in another seat for the purposes of calculating seat status would not reflect their independent status. Others may wish to do this, but the AEC cannot. As such, notional margins for Independent candidates in redistributed seats will appear lower than the margins Independent candidates won by at the 2022 federal election.

#### Neighbouring non-classic pairings

CONSIDE

Electoral divisions that have been redrawn since the 2022 federal election, that neighbour each other, and have the same non-classic pairing, are likely to show a starting margin that is different to some calculations done by those external to the AEC.

This is largely due to a methodology for calculating such notional margins in the AEC's legacy election management systems that does not make assumptions about how voters at this small subset of polling places may have voted in their new electoral division.



# Seat margins

Note: The last column in the following tables lists the swing required to win or lose a seat. In each case an extra vote would be required to achieve a 50% +1 majority.

# 'Non-classic' seat margins

At the previous federal election in 2022 there were 27 seats where the final two candidates were not the ALP and the Coalition. These seats are commonly referred to as 'non-classic' contests.

One non-classic seat at the 2022 federal election – North Sydney – has since been abolished as part of the NSW redistribution process. The margins for the remaining 26 non-classic seats are as follows.
